1.

9 The Oregon Medical Board (Board) is the state agency responsible for licensing,
10 regulating and disciplining certain health care providers, including physicians, in the State of
11 Oregon. Timothy Owen O'Dea, MD (Licensee) is a licensed physician in the State of Oregon.

13 On March 18, 2022, the Board opened an investigation after receiving credible
14 information regarding Licensee's possible violation of the Medical Practice Act, specifically, his
15 ability to safely and competently practice medicine. On May 6, 2022, Licensee entered into an
16 Interim Stipulated Order in which he voluntarily agreed to withdraw from practice pending the
17 completion of the Board's investigation.

19 Licensee and the Board desire to settle this matter by the entry of this Stipulated Order.
20 Licensee understands that he has the right to a contested case hearing under the Administrative
21 Procedures Act (Oregon Revised Statutes chapter 183) and fully and finally waives the right to a
22 contested case hearing and any appeal therefrom by the signing of and entry of this Order in the
23 Board's records. Licensee neither admits nor denies, but the Board finds, that Licensee engaged
24 in conduct that violated the Medical Practice Act, to wit: ORS 677.190(1)(a) unprofessional or
25 dishonorable conduct, as defined in ORS 677.188(4)(a) any conduct, practice or condition which
26 does or might adversely affect a physician's ability to safely and skillfully practice medicine.
27 Licensee understands that this Order is a public record and is a disciplinary action that is

1 reportable to the National Practitioner Data Bank and the Federation of State Medical Boards.

2 Licensee understands the terms of this Order and signs freely, without fraud or duress.

3 4.

4 Licensee and the Board agree that the Board will close this investigation and resolve this
5 matter by entry of this Stipulated Order, subject to the following conditions:

6 4.1 Licensee surrenders his Oregon medical license while under investigation.

7 4.2 Licensee must not reapply for a medical license in the State of Oregon for at least
8 two years from the effective date of this Order.

9 4.3 The May 6, 2022, Interim Stipulated Order terminates effective the date the Board
10 Chair signs this Stipulated Order.

11 4.4 Licensee must obey all federal and Oregon state laws and regulations pertaining
12 to the practice of medicine.

13 4.5 Licensee stipulates and agrees that any violation of the terms of this Order shall
14 be grounds for further disciplinary action under ORS 677.190(17).

16 This Order becomes effective the date it is signed by the Board Chair.
