9 The Oregon Medical Board (Board) is the state agency responsible for licensing,
10 regulating and disciplining certain healthcare providers, including physicians, in the State of
11 Oregon. Brian Mathew Bowen, DPM (Licensee) is a licensed podiatric physician in the State of
12 Oregon.

14 The Board received credible information regarding Licensee that resulted in the Board
15 initiating an investigation and issuing an Interim Stipulated Order on December 15, 2023. Since
16 that time, additional investigations have been opened. In order to address the Board's concerns
17 while these matters are under investigation, Licensee and the Board agree to the entry of this
18 Interim Stipulated Order, which is not an admission of any wrongdoing on the part of the
19 Licensee. Licensee understands the terms of this Order and signs freely, without fraud or duress.

21 While these matters are under investigation, Licensee agrees to the following conditions:

22 3.1 Licensee voluntarily withdraws from the practice of podiatric medicine, and his
23 license is placed in Inactive status pending the completion of the Board's investigations into his
24 ability to safely and competently practice podiatric medicine.

25 3.2 Licensee understands that violating any term of this Order will be grounds for
26 disciplinary action under ORS 677.190(17).

3.3 This Interim Stipulated Order supersedes the Interim Stipulated Order of December 15, 2023.

3.4 Licensee must notify the Oregon Medical Board within 10 days as to how patients may access or obtain their medical records.

At the conclusion of the Board's investigations, Licensee's status will be reviewed in an expeditious manner. Following that review, if the Board determines that Licensee shall not be permitted to return to the practice of podiatric medicine, Licensee may request a hearing to contest that decision.

This Order is issued by the Board pursuant to ORS 677.265(1) and (2) for the purpose of protecting the public, and to allow the Board to complete its investigation in order to fully inform itself with respect to the performance or conduct of the Licensee and Licensee's ability to safely and competently practice podiatric medicine. Pursuant to ORS 677.425, Board investigative materials are confidential and shall not be subject to public disclosure. However, as a stipulation, this Order is a public document and is reportable to the National Practitioner Data Bank and the Federation of Podiatric Medical Boards. This Order becomes effective the date it is signed by the Board's Executive Director or Medical Director in accordance with OAR 847-001-0030.
