9 The Oregon Medical Board (Board) is the state agency responsible for licensing,
10 regulating and disciplining certain health care providers, including physicians, in the State of
11 Oregon. Thomas Richard Eubanks, DO (Licensee) is a licensed physician in the State of
12 Oregon.

2.

14 On February 28, 2021, Licensee entered into an Interim Stipulated Order with the Board
15 in which he agreed to voluntarily withdraw from practice and place his license in Inactive status
16 pending the completion of the Board's investigation. On March 22, 2022, the Board issued a
17 Complaint and Notice of Proposed Disciplinary Action in which the Board proposed to take
18 disciplinary action against Licensee pursuant to ORS 677.205(2), specifically: revocation of his
19 medical license; a civil penalty of \$10,000; and assessment of costs of any contested case hearing
20 on the matter not to exceed \$40,000. The Board proposed to take this disciplinary action for
21 violations of the Medical Practice Act, specifically: ORS 677.190(1)(a) unprofessional or
22 dishonorable conduct, as conduct unbecoming a person licensed to practice medicine or
23 detrimental to the best interest of the public, specifically ORS 677.188(4)(a) any conduct or
24 practice contrary to recognized standards of ethics of the medical profession, and OAR 847-010-
25 0073(3)(b)(G) sexual misconduct.

2 Licensee and the Board desire to settle this matter by the entry of this Stipulated Order.
3 Licensee understands that he has the right to a contested case hearing under the Administrative
4 Procedures Act (Oregon Revised Statutes chapter 183), and fully and finally waives the right to a
5 contested case hearing and any appeal therefrom by the signing of and entry of this Order in the
6 Board's records. Licensee neither admits nor denies, but the Board finds that Licensee engaged
7 in conduct as described in the March 22, 2022, Complaint and Notice of Proposed Disciplinary
8 Action, and that this conduct violated the Medical Practice Act, to wit ORS 677.190(1)(a),
9 specifically ORS 677.188(4)(a), and OAR 847-010-0073(3)(b)(G). Licensee understands that
10 this Order is a public record and is a disciplinary action that is reportable to the National
11 Practitioner Data Bank and the Federation of State Medical Boards. Licensee understands the
12 terms of this Order and signs freely, without fraud or duress.

14 Licensee and the Board agree that the Board will close this investigation and resolve this
15 matter by entry of this Stipulated Order, subject to the following conditions:

16 4.1 Licensee retires his Oregon medical license while under investigation, and
17 Licensee agrees never to reapply for a license to practice medicine in Oregon.

18 4.2 Licensee is assessed a civil penalty of \$8,000.00. This term is held in abeyance as
19 long as Licensee does not violate any term of this Order.

20 4.3 The Interim Stipulated Order of February 28, 2021, terminates effective the date
21 the Board Chair signs this Stipulated Order.

22 4.4 Licensee must obey all federal and Oregon state laws and regulations pertaining
23 to the practice of medicine.

24 4.5 Licensee stipulates and agrees that any violation of the terms of this Order shall
25 be grounds for further disciplinary action under ORS 677.190(17).
