9 The Oregon Medical Board (Board) is the state agency responsible for licensing,
10 regulating and disciplining certain health care providers, including acupuncturists, in the State of
11 Oregon. Kyle Kazuharu Yoshioka, LAc (Licensee) is a licensed acupuncturist in the State of
12 Oregon.

14 On February 18, 2022, the Board opened an investigation after receiving credible
15 information regarding Licensee's possible violation of the Medical Practice Act, specifically
16 sexual misconduct. On March 31, 2022, Licensee entered into an Interim Stipulated Order to
17 voluntarily withdraw from practice and place his license in Inactive status pending the
18 completion of the Board's investigation.

20 Licensee and the Board desire to settle this matter by the entry of this Stipulated Order.
21 Licensee understands that he has the right to a contested case hearing under the Administrative
22 Procedures Act (Oregon Revised Statutes chapter 183), and fully and finally waives the right to a
23 contested case hearing and any appeal therefrom by the signing of and entry of this Order in the
24 Board's records. Licensee neither admits nor denies, but the Board finds that Licensee engaged
25 in conduct that violated the Medical Practice Act, to wit: ORS 677.190(1)(a) unprofessional or
26 dishonorable conduct, as defined in ORS 677.188(4)(a), and as further defined in OAR 847-010-
27 0073(3)(b)(F) sexual misconduct. Licensee understands that this Order is a public record and is

1 a disciplinary action that is reportable to the National Practitioner Data Bank and the National
2 Certification Commission for Acupuncture and Oriental Medicine. Licensee understands the
3 terms of this Order and signs freely, without fraud or duress.

5 Licensee and the Board agree that the Board will close this investigation and resolve this
6 matter by entry of this Stipulated Order, subject to the following conditions:

7 4.1 Licensee surrenders his Oregon acupuncture license while under investigation.

8 4.2 Licensee must not reapply for an acupuncture license in the State of Oregon for at
9 least two years from the effective date of this Order.

10 4.3 The March 31, 2022, Interim Stipulated Order terminates effective the date the
11 Board Chair signs this Stipulated Order .

12 4.4 Licensee must obey all federal and Oregon state laws and regulations pertaining
13 to the practice of acupuncture.

14 4.5 Licensee stipulates and agrees that any violation of the terms of this Order shall
15 be grounds for further disciplinary action under ORS 677.190(17).

16

17 This Order becomes effective the date it is signed by the Board Chair.
