The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers, including osteopathic physicians, in the State of Oregon. Paul Jeffrey Aanderud, DO (Licensee) is a licensed osteopathic physician in the State of Oregon.

2.

On January 5, 2018, the Board issued a Complaint and Notice of Proposed Disciplinary Action (Notice) in which the Board proposed to take disciplinary action by imposing up to the maximum range of potential sanctions identified in ORS 677.205(2), to include the revocation of license, a \$10,000 fine, and assessment of costs, pursuant to ORS 677.205 against Licensee for violations of the Medical Practice Act, to wit: ORS 677.190(1)(a) unprofessional or dishonorable conduct, as defined by ORS 677.188(4)(a); and ORS 677.190(13) gross or repeated acts of negligence. Prior to the issuance of the Notice, on July 31, 2017, Licensee entered into an Interim Stipulated Order with the Board in which he agreed to voluntarily cease performing Mohs surgery on any patient pending the completion of the Board's investigation.

3.

Licensee and the Board desire to settle this matter by entry of this Stipulated Order. Licensee understands that he has the right to a contested case hearing under the Administrative Procedures Act (chapter 183), Oregon Revised Statutes. Licensee fully and finally waives the right to a contested case hearing and any appeal therefrom by the signing of and entry of this Order in the Board's records. Licensee neither admits nor denies, but the Board finds that

1 Licensee's conduct as described in the January 5, 2018, Complaint and Notice of Proposed  
2 Disciplinary Action violated ORS 677.190(1)(a), as defined by ORS 677.188(4)(a); and ORS  
3 677.190(13). Licensee understands that this Order is a public record and is a disciplinary action  
4 that is reportable to the National Practitioner Data Bank and the Federation of State Medical  
5 Boards.

6 4.

7 Licensee and the Board agree to resolve this matter by the entry of this Stipulated Order  
8 subject to the following terms and conditions:

9 4.1 Licensee is reprimanded.

10 4.2 Licensee must pay a civil penalty of \$10,000 within 90 days from the effective  
11 date of this Order.

12 4.3 Licensee is placed on probation for a period of 10 years and shall report in person  
13 to the Board at each of its quarterly meetings at the scheduled times for a probation interview,  
14 unless otherwise directed by the Board's Compliance Officer or its Investigative Committee.  
15 Additionally, at the Board's discretion, interviews may be held electronically between Licensee  
16 and the Board's Compliance Officer (or its designee) using Board established protocols for the  
17 location and electronic transmission of the meeting. Licensee is responsible for maintenance of  
18 the equipment and technology necessary for the electronic meetings to occur. Licensee will be  
19 notified if and when such meetings are scheduled in lieu of an in-person appearance. Licensee  
20 may request modification of this term after five years of continued compliance with all terms of  
21 this Order.

22 4.4 Licensee may practice general dermatology, but Licensee must not perform Mohs  
23 surgery on any patient at any time.

24 4.5 Licensee must use a certified pathology lab for histological analysis and must not  
25 perform histological analysis on any samples.

26 4.6 Licensee, and Licensee's employees acting under his supervision, must  
27 photograph any lesions prior to removal. Photographs must include a ruler next to the lesion to

1 document the size of the lesion, and the photograph must be included as part of the medical  
2 record.

3 4.7 Licensee must notify all patients of histologic results within ten business days of  
4 his receiving the pathology reports.

5 4.8 Within six months from the effective date of this Order, Licensee must complete  
6 an ethics course that has been pre-approved by the Board's Medical Director.

7 4.9 Within six months from the effective date of this Order, Licensee must complete a  
8 course in professionalism that has been pre-approved by the Board's Medical Director.

9 4.10 Within six months from the effective date of this Order, Licensee must complete a  
10 documentation course that has been pre-approved by the Board's Medical Director.

11 4.11 At the discretion of the Board or its designees, random, no notice chart audits and  
12 office visits may be conducted by Board designees.

13 4.12 Licensee must inform the Compliance Section of the Board of any and all practice  
14 sites, as well as any changes in practice address(es), employment, or practice status within 10  
15 business days. Additionally, Licensee must notify the Compliance Section of any changes in  
16 contact information within 10 business days.

17 4.13 The Interim Stipulated Order of July 13, 2017, terminates upon the effective date  
18 of this Order.

19 4.14 Licensee must obey all federal and Oregon state laws and regulations pertaining  
20 to the practice of medicine.

21 4.15 Licensee stipulates and agrees that any violation of the terms of this Order shall  
22 be grounds for further disciplinary action under ORS 677.190(17).
